- A. Rule 6.6 Retired License Status add sentence which would allow for the Board to consider a request for retired status from those younger than seventy-five (75) years of age;
- B. Chapter 7, Continuing Education Rule 7.1, 7.2, 7.3, and 8.6 make clear that continuing education courses must be approved prior to receiving CE credit;
- C. Rule 10.4 Consent Orders clarify a Consent Order is not subject to appeal;
- D. Rule 10.8 Recusal clarify a substitute member's scope is limited to the disciplinary proceeding; and
- E. Chapter 11, Advertising Rule 11.1, 11.2, and 11.3 remove 'unlicensed'. The vote was unanimous. Motion carried.
